On Tuesday, May 18, 2021, the Lexington County School District One Board of Trustees holds a board meeting in Building One of Central Services' auditorium located at 100 Tarrar Springs Road in Lexington, South Carolina.

The meeting opens at 6 p.m. in the auditorium. The board will promptly vote to enter executive session to discuss employment recommendations for 2021–2022. This closed executive session will take place in the auditorium. The Board of Trustees will resume the public portion of its meeting at 7 p.m.
