- Rental Lease (complete copy, listing all occupants)
- Real Estate Closing Documents (where applicable)
- Complete a Residency Declaration Affidavit Form. You can pick up this form in the front office. This form needs to be notarized or witnessed by a school representative.

## STEPS FOR THE PARENT/GUARDIAN:

1) Each school year the Parent/Guardian is required to provide <u>TWO DOCUMENTS OF MAIL</u> in your name that show the address of the person with whom your family resides. Junk mail is not acceptable.

Acceptable documents include:

- Paycheck stub
- W-2 statement
- Car insurance
- Bank statement
- State supported services
- Voter registration card
- Vehicle tax registration
- Cell phone bill.

A driver's license will be required from the property owner and parent or legal guardian for identification purposes only. IDs cannot be accepted as documentation for address verification.
