South Carolina Child ID Kits

In 2022, the South Carolina General Assembly passed S.1103, the South Carolina Child ID law. This law requires Child ID kits be made available to the parents of our K-12 students. These kits allow parents to have their child's vital information stored in a safe place, at home, in the event of an emergency. Districts are required to notify parents of the availability of the Child ID kits and provide the kits. We will soon communicate the availability of these kits at our schools, and distribute them to parents who request them.

Project PRISMS: Providing Resources to Increase School Mental Health Support is a 5-

year, \$5 million project funded by the U.S. Department of Education. The project is a partnership between The University of South Carolina (USC) Counselor Education program and three local education agencies (LEAs): Aiken County Public School District (ACPSD), Lexington County School District One (LCSD1), and Richland County School District 2 (RCSD2) to recruit, train and support highly qualified school-based mental health services providers. USC, in partnership with ACPSD, LCSD1, and RCSD2 will provide funding and train 72 total graduate students in two school-based mental health specializations within the five-year project period. We will train graduate students to become South Carolina certified school counselors or school-based mental health counselors.
