Yesterday an LHS student was exhibiting concerning behavior. Quickly, school administrators, our school resource officers and district security personnel investigated. There was no immediate threat to the school. Following <u>Board Policy JICDA Code of Conduct</u> and <u>JICDA-R</u> the student has been suspended and recommended for expulsion.The student is being charged by Lexington County Sheriff's Department.

## **HUMAN RESOURCES**

#### Exit Meeting Process

Many have asked what the exit process looks like in Lexington One. Once the employee has submitted form HR44, the HR process begins, with the employee receiving a notice similar to the one linked <u>here</u>, along with other documents. We give all employees an opportunity to meet in person. Certified employees also have the option to complete an anonymous exit survey. We are currently working through the process of developing an exit survey for support staff as well.

#### INSTRUCTIONAL SERVICES

At the May 16 board meeting, a parent and student shared concerns about the decision not to offer Latin at MGMS next year. Due to ongoing staffing challenges, we are unable to offer Latin at RBHS; thus, MGMS is no longer offering Latin as an option. MGMS will continue to offer Chinese, French and Spanish and RBHS will continue to offer Chinese, French, German and Spanish. LHS, WKMS and WKHS will still offer Latin. A student who wants to take Latin may transfer to those schools. The district remains committed to a robust World Language program.

### Vape Detectors

We are working with procurement to put out a bid for vape detectors to be installed in middle and high school restrooms. The plan is to use funding from the Juul settlement to fund this effort. The goal is to have the bid process complete so that when funding is available, we can move quickly.

<u>New Transportation Facility</u> - Staff will begin relocating to the new facility on June 6th. District operations and IT staff will provide support for the transition.
