A board member asked about the differences between the Cognia School Accreditation visit in 2022 and the recent 2024 Curriculum Management System audit--purposes, costs, use of outcomes, etc. Please see our full response <a href="here">here</a>. Bottom line:

Accreditation	Curriculum Audit
Cognia is a less intensive check up of a district to determine if the district is operating at a quality deserving of accreditation. It is a policy tool for quality assurance. In other words, are credits students earn in our schools reflective of SC standards and worthy of being accepted by other K-12 schools in the US and beyond?	A Curriculum Audit is a much more intensive examination, often requested by practitioners who want to dig deeply into the details of sub-systems to determine where to start making improvements that ensure the same high-quality curriculum is delivered consistently across the district.
