

New SC Mathematics Course Sequence



In the 2025-26 school year Geometry with statistics will be offered in 9th grade, followed by Algebra I and then at least two more math courses. Effective that year, Lex One will offer Honors Geometry with Statistics in 8th grade for students who are academically ready.

Literacy Training for All K-3 Teachers

The General Assembly has funded LETRS professional learning for K-3 educators. The state budget includes training for all K-3 teachers, school administrators, reading coaches, reading interventionists, and K-3 special education teachers.

March 18 - South Carolina Day

March 18th has been designated as South Carolina Day by the South Carolina Legislature. To honor South Carolina day, schools and teachers help students gain a more general knowledge and appreciation of the history, resources, and possibilities of this State.

A4LE Excellence Award

Last week, SC DHEC updated their medical exclusion list to reflect that students and staff may return after testing positive for COVID once they have been fever-free for 24 hours.

4K Programs Pay Big Dividends

The Education Oversight Committee's annual evaluation of South Carolina's Child Early Reading and Development Education Program (CERDEP) found that students who participated in state-funded full-day 4K CERDEP were more likely to demonstrate readiness on the Kindergarten Readiness Assessment (KRA) than those who did not. Of the 57,804 enrolled kindergarten students for the 2023-24 school year, 35,932 were considered Pupils in Poverty. Of this PIP population, forty percent were served by CERDEP. Taken from the March 13 edition of e-clippings from SCSBA: [The house approved their budget and sent it to the Senate.] SCSBA thanks school board members, especially board members on the SCSBA A-Team, for their successful advocacy efforts in urging House members to support passage of Amendment 34 by Rep. Chris Wooten of Lexington County that adds a budget proviso allowing state retirees to work as school bus drivers and not be subject to a cap on their retirement pay. The House unanimously approved the amendment and included a round of applause by lawmakers after the vote.
