Next week, parents/guardians of students in grades 6-12 will receive communication regarding the Lexington One Community Coalition (LOCC) student survey. In order for a student to take the survey, a parent/guardian must give

consent using the form in Parent Portal. The form gives the contact information of the district's director of School Counseling and Advisement if a parent/guardian wants to preview the survey before giving consent. The survey assesses the thoughts and perceptions of drug and alcohol usage from the viewpoint of the student and is offered to students bi-annually. The data collected from this survey, which is confidential and anonymous, allows the district to offer prevention programs and gain awareness about trends. The survey will be administered during the week of November 6th to students whose parents/guardians give consent.

#### Medicaid to Cover Autism Services

We received news this week that SC Medicaid will now cover autism services, and school districts can enroll with Medicaid as ASD providers. The <u>ADS Services Provider Manual</u> provides info about covered services, staff qualifications, etc. Historically, districts were told that they could not be reimbursed for autism services or enroll as providers. However, the SC DHHS has now confirmed that districts can enroll, Lex One will do so ASAP.
