FINANCE

A new <u>S.C.Education Funding Dashboard</u> went live October 25, 2023. Maintained by the S.C. Revenue and Fiscal Affairs, the dashboard summarizes funding and expenditures for K-12 education for Fiscal Year 2021-2022, prior to the rollout of the new funding formula that started in Fiscal 2022-2023. Currently, the dashboard allows users to analyze and compare revenues, expenditures, academic achievement, and other data by district. As more data and additional years become available, more options and longitudinal analysis will be added. A "How To Guide" is available on the SCRFA website.

INSTRUCTIONAL SERVICES

Adult Education

The Lexington One Adult Education program is experiencing rapid growth, especially in students aged 17-19 who fell behind academically when COVID impacted their school experience. These students who dropped out of high school are now seeking their High School Equivalency Diploma (GED). Over 200 students have passed three out of four sections of the GED. To meet the needs of the increased demand, the district will leverage ESSER funds to add additional sections of ELA and Math to serve up to 30 additional students at a given time. As space permits, the program will continue to add additional sections. Since the state funding that supports adult education programs is based on the previous year's performance, the district anticipates that the funding received next year will support the increased enrollment.

<u>Comprehensive Health Education Advisory</u> Committee

Since the CHEA committee first convened in Spring 2023, two students graduated and one teacher is no longer in the district. The board approved the current student body presidents at Gilbert High, Grace Bedenbaugh, and River Bluff High, Ayden Higingbottom, to serve on the committee, as well as Brandi Humble, health education teacher at Beechwood Middle School.
